ORDER

Sub: Collectorate-KKL-Release of II & Final installment Subsidy amount for Construction of Sanitary Latrine – Expenditure Sanction-Accorded

Ref: I.D. Note No.10/AWD/KK/dt. 02.09.2016 of the Assistant Director of Adi Dravidar Welfare Department, Karaikal.

In exercise of the powers delegated to the undersigned Vide G.O. Ms. No.47/F3/2014, dt.09.12.2014, of the Finance Department, Puducherry, sanction is hereby accorded to incur an expenditure not exceeding **Rs. 40,000/- (Rupees Forty Thousand only)** towards the payment of 2nd & Final installment subsidy amount for construction of sanitary latrine to 4 beneficiaries @ Rs. 10,000/- per beneficiary under the scheme. "Grant of Financial Assistance to the below poverty line Scheduled Caste families for construction of Sanitary Latrines in Karaikal District for the year 2016 as detailed in the Annexure.

2. The Assistant Director, Adi Dravidar Welfare Department, Karaikal has certified that all the conditions prescribed to receive IInd & Final installment amount under the Rules of the scheme are fulfilled by the beneficiaries concerned.

3. The amount sanctioned shall be drawn by the Assistant Director, Adi Dravidar Welfare Department, Karaikal and disbursed by means of cheque to the beneficiaries concerned after getting proper acquittance from them.

4. The Assistant Director is further instructed to submit the acquittance obtained from the beneficiaries for the disbursement of amount, to the Collectorate within 30 days from the date of drawal of amount.

5. The expenditure is debitable to the head of account, "2225-Welfare of Scheduled Castes, Scheduled Tribes, and Other Backward Classes-01/Welfare of Scheduled Castes - 01/789-Special Component Plan for Scheduled Castes 01/789(28)- Construction of Low Cost Dwelling Units Development of Housing Colonies / House Sites and Grant of House Construction Subsidies-01/789(28) (02) – Karaikal Region (33) Subsidies-Plan" in the budget of the current financial year.
