ORDER

In exercise of the powers delegated to the undersigned vide G.O. Ms. No.47/F3/2014, dt.09.12.2014 of the Finance Department, Puducherry, sanction is accorded for incurring of an expenditure not exceeding to **Rs. 80,000/- (Rupees Eighty Thousand only)** towards the payment of financial assistance to **8** families of deceased poor Schedule Caste people for having performed Funeral Rites @ Rs. 10,000/- each belonging to Karaikal District under the Scheme "Grant of Financial Assistance to Scheduled Caste People to perform Funeral Rites" as detailed in the annexure.

2. The Assistant Director, Adi Dravidar Welfare Department, Karaikal has certified that the beneficiaries are found eligible for the assistance as per the conditions laid down under the rules of the scheme amended from time to time.

3. The amount shall be drawn by the Assistant Director, Adi Dravidar Welfare Department, Karaikal and disbursed by means of cheque after obtaining proper acknowledgement from the beneficiaries concerned.

The expenditure is debit to the Head of Account "2225- Welfare of Scheduled Caste/ Scheduled Tribes and Other Backward classes- 80 General 80/800 Other expenditure 80/800 (02) Financial Assistance to Scheduled Caste persons to perform Funeral Rites- 80/800 (02) (02) - Karaikal Region- 50- Other Charges- **Non- Plan**" in the budget of the current financial year.
