2. The Assistant Director, Adi Dravidar Welfare Department, Karaikal has certified that all the conditions prescribed to receive the third & final instalment amount had been fulfilled by the beneficiaries.

3. The amount sanctioned shall be drawn by the Assistant Director, Adi Dravidar Welfare Department, Karaikal and disbursed by means of cheque to the beneficiaries after getting proper acquittance from them.
