The expenditure is debit to the head of account, "2235-Social Security and Welfare-60 Other Social Security and Welfare Programme-60/101(01)-Group Personal Accident Insurance Scheme for Below Poverty Line family members (02)-Karaikal Region-(50)-Other Charges (Non-Plan)" in the Budget of the Current Financial Year.
