2. The Financial assistance to the beneficiaries listed in Form-C under reference 2<sup>nd</sup> cited above shall be paid through 'ECS' to the bank accounts maintained by the beneficiaries in the respective nationalized/scheduled banks in the Union Territory of Puducherry.

3. The expenditure is debitable to the head of account, "2235-Social Security and Welfare-60 Other Social Security and Welfare Programme-60/101(01)-Group Personal Accident Insurance Scheme for Below Poverty Line family members (02)-Karaikal Region-(50)-Other Charges (Non-Plan)" in the Budget.
