PROCEEDINGS OF THE PERSONAL INTERVIEW CONDUCTED FOR THE SELECTION OF VILLAGE LEVEL ENTREPRENEURS FOR THE ESTABLISHMENT OF COMMON SERVICE CENTRES IN VACANT WARDS OF KARAIKAL MUNICIPALITY (URBAN LEVEL) HELD ON 15/12/2016 AT 11.00 AM IN THE CHAMBER OF DISTRICT COLLECTOR cum CHAIRMAN KDeGS, KARAIKAL

Scrutiny of application & Personal interview for the selection of Village Level Entrepreneurs (VLE's) for the establishment of CSC 2.0 in as many as 14 Wards of Municipal limit was held on 15/12/2016 at 11.00 AM as scheduled in the chamber of the Collector-cum-Chairman, Karaikal District e-Governance Society, Karaikal.

As per Guidelines for the implementation of the CSC 2.0 - A way forward under Digital India Programme, wide publicity was given in the leading daily / official website and a scrolling message in the local television channels inviting applications from willing / interested entrepreneurs for the establishment of CSC in the 14 vacant Wards of Karaikal Municipality (Urban Limit) was arranged. As many as 57 applicants had submitted their applications for establishment of CSC's at various Wards of Karaikal Municipality.

All the applicants were informed through e-mails / NIC message services apart from normal postal services to attend the verification / personal interview. Out of the 57 applications 1 was received from Vadakku Vanjore Village Panchayat which is left as vacant while selecting the VLE for rural gram panchayat locations. The applicants who have submitted their applications for urban limits while calling for the Rural Centres were also included in the selection process. All are taken into account and total application received as on prescribed date accounts to 57 in Nos.

Out of 57 applicants, 6 did not turn up for the Interview cum selection process. The applications were scrutinized and found to be in order. The status of the applications is as follows :

As per terms and conditions of DelTY, the applicant must be a permanent resident of Karaikal Municipality hailing from the ward and he / she is willing to set up the CSC in his/her Ward then the individual will be preferred for selection. After careful examination of the applications received, it is learnt that **Only one Ward (Amman Kovilpathu)** has been preferred by **only single applicant** and it was allotted to him. The one who had submitted applicant for Rural Vanjore centre was also selected. Another **Eleven** were also allotted to their respective Wards based on their performance in the Personal Interview cum selection Process. Only **Two** were granted in alternate Wards other than their own residential area based on the guidelines stipulated in the CSC project mentioned here-below.


"the state / UT would have the flexibility of selecting the VLE for setting up of CSC Network at the Gram Panchayat level under various combinations as suitable to the prevailing Conditions"

It is significant to point out here that all are granted with VLE's in their respective Wards. All the fourteen vacant wards were filled and the one gram panchayat (ie Vanjore) left vacant / unfilled during VLE selection to rural areas was also now filled. The provisionally selected list of Village Level Entrepreneurs for setting up of CSC's in 14 Wards and Vanjore Gram pachayat location is enclosed in the Annexure.


The selected applicants may be allotted with respective Wards subject to the production of latest Residence Certificate and a copy of the PAN Card. Further allotment shall be subject to their ability to establish the CSC within one month from the date of issue of order and failing which the allotment is liable for cancellation. Requests for extending the setting up of CSC beyond prescribed limit will not be entertained. Canvassing in any form also liable to cancellation of the orders. The Committee has the power to withdraw / cancel the allotment at any time for any reasons assigned therefor.
